Registration Fee (mandatory for all applicants)

The registration fee and the call fee are entry level membership for funeral home establishments. Monies collected are used to lobby and advocate for independent funeral homes on legislative issues that affect our profession. Each registered location is entitled to 1 vote on all matters of the Association. Owners/Managers will be invited to discuss current sector issues and participate on OFSA committees and the Board of Management.

*Combined Registered Calls (mandatory for all applicants)

This # represents the funeral homes registered calls reported to the BAO from November 1 – October 31 annually. You are required to combine calls for all affiliated locations as per the OFSA By-laws.

Continuing Education

The fee of \$125 provides staff with 6+ hours of continued education annually on demand at www.ofsaeducation.org and monthly live webinars. This online site tracks completed education sessions and issues certificates of completion. All Education fees collected are for developing continuing education for Ontario funeral professionals.

WHMIS Training Ontario business are required to provide WHMIS training annually for all staff. This online training is funeral home specific with lessons and a final quiz. A certificate of completion is issued.

GM Fleet Discounts These discounts range from\$1,500 – \$5,500. Discount sheets are published annually. To claim this discount, you must request a letter of authorization from the OFSA office.
